backside LINE: an okay access during this lengthy series, full of plenty of folksy bits and a tiny glimmer of a pointy plot lurking within the background. Unfortunately, there is an excessive amount of "folksy" and 'way too little plot for my taste. Wildfire season, arson settings, land speculation, undercover investigations, new inhabitants, and the loss of life of an previous friend, makes Qwilleran lengthy for "The titanic One" (the first storm from snow of the season) because it could suggest per week of peace and quiet. And Polly's jealousy of each girl in sight wears on Qwill's (and our) nerves too. Has "the usual" praise of too many folks stories instructed to Qwill through outdated folks, plenty of lovable "doings" via the townsfolk, and turns out to slide more and more into fluff. but there are glimmers of a very tremendous plot during this very slender book, particularly about the dying of an in depth good friend of Qwill; regrettably this a part of The Cat Who Smelled a Rat (The Cat Who... #23) the tale is going nowhere, with a frothy windup that ignores a great deal of the buildup, and is going for the "feel good" ending. I'm getting uninterested in Qwill utilizing his funds to "make issues nice" for the entire strong fogeys in Pickaxe, time after time after time. The layout of those tales hasn't replaced in ten years, with different bits seeming simply plugged in, a truly "templated" kind of novel. Too bad, Braun wrote 3 really good books within the Sixties and several other excellent ones within the early 80s, however the sequence has degenerated right into a "nice stopover at with the house folks" thang only. i admire maintaining with Qwill and the folks, but...have reread this sequence a number of times, this time in audio; George Guidall has narrated each ebook during this series, and does an exceptional activity with all of them, even the fewer entertainingly plotted ones, The Cat Who Smelled a Rat (The Cat Who... #23) together with this.
